TOP TEN REASONS FOR CHAOS IN LAUSD

- 10. Line/staff communication to principals is not always timely nor does it often follow protocol.
- 9. Title I money sent to schools with no training for site councils and a very limited level of oversight/accountability.
- 8. Principals who no longer will have an assistant principal needing to spend up to three hours daily on playground supervision instead of leading the instructional program and supervising staff or responding to parents. This will also reflect a serious safety concern because no one will be available when the principal needs to be away from the campus.
- 7. Principals trying to schedule and attend up to an additional 100 IEP meetings many of which can take two or more hours.
- 6. Inability to respond in a timely manner to parent concerns due to the lack of administrative and office personnel.
- 5. Instability of staffing assignments due to the unnecessary wholesale movement of personnel caused by reductions in force that could be avoided if stimulus monies were used appropriately.
- 4. Potential staff and student unrest due to increased class size and decreased adult supervision.
- 3. Markedly reduce staff morale caused by anxiety, insecurity, and negativity.
- 2. Lack of inspiration from the Superintendent and the majority of the Board of Education Members.
- 1. And the number one reason why there is chaos in the District: Allocated stimulus money not being fully used as authorized by President Obama to save jobs and prevent chaos.

REPRESENTATIVE ASSEMBLY MEETING REPORT

The fourth and final AALA Representative Assembly meeting of the 2008-2009 school year was held on May 14, 2009. The tentative 2009-2010 AALA budget was approved. President Mike O'Sullivan announced the AALA election results: Dr. Judith Perez, President; Margaret Prietto, Secondary Dept. Vice President; Dr. Howard Saxe, Adult Dept. Director; Marsha Oh-Bilodeau, Supervisory Dept. Director; and Dr. Angel Barrett, Elementary Dept. Vice President. The Elementary Department caucus elected Ken Urbina as Elementary Dept. Director to replace Dr. Perez. Supervisory Dept. elected Ms. Oh-Bilodeau as Supervisory Dept. Vice President to replace Lynn Williams who announced her retirement, and elected Manuel Caldera as Supervisory Director to replace Barbara Huff who also announced her retirement. In addition, the Supervisory Dept. elected Doug Waybright to replace Ms. Oh-Bilodeau as Director. Dr. Fred Hermosillo, Adult Dept. Vice President, announced his retirement, and the Adult Dept. will need to elect a new Vice President at the next Adult Dept. Caucus meeting.

AALA was pleased to welcome and introduce newly elected Board of Education Member **Steve Zimmer** to the Representative Assembly. Mr. Zimmer is replacing **Marlene Canter** on the Board. He stressed the need for collaboration among all interest groups in the District with the focus on what is best for our students. His comments were appreciated.

The re-opener for the second/third years of the AALA/LAUSD bargaining agreement MOU was ratified. In addition to some language changes, the main benefit was the stipulation that District mileage for AALA represented employees will now be based on the prevailing IRS rate.

A PAC report was also given.

Representative Assembly members expressed their appreciation to President Mike for his six years of outstanding service.

FIVE SUGGESTIONS FOR THOSE FEDERAL STIMULUS FUNDS

The Coalition for Student Achievement, convened in response to the American Recovery and Reinvestment Act, is comprised of 50 national organizations. In early May it issued five recommendations for governors, state school officers, superintendents, and other education leaders on how to invest federal stimulus dollars to leverage significant increases in student performance. **The group recommends:** developing national standards for testing; producing data that educators, policymakers, and parents can use; evaluating teachers in a meaningful way; turning around low-performing schools; and helping struggling students. If these recommendations are undertaken, the group says, by 2012 Americans will see at least 40 states adopting evidence-based, college- and career-ready testing standards; students, parents, teachers, principals, district, and state leaders will have comprehensive data that show what's working for students; clear, differentiated teacher evaluation systems will be in every state and school district; neighborhoods served by the lowest-performing five percent of schools will have new, quality education options; and students at least two years behind in reading, writing, and mathematics will get targeted interventions. "Transformation will happen only if state and district leaders are willing to take advantage of this investment opportunity," the recommendations say. "The forces of inertia are powerful... The time for bold action is now."

LAUSD ATHLETIC HALL OF FAME

The Los Angeles Unified School District can arguably say it has graduated more national and international class athletes than any other school district in the world. These athletes have competed in sports as diverse as football, gymnastics, track and field, swimming, boxing, golf, wrestling and automobile racing, and sports-related fields such as coaching, officiating, and media. Athletes like **Bob Waterfield, Gail Goodrich, Oscar De La Hoya, Mal Whitfield, Sammy Lee,** and **Cynthia Cooper** have put the LAUSD stamp on the history of world athletics.

To recognize this, the Interscholastic Athletic Committee (IAC) has begun the process of establishing the Los Angeles Unified School District Athletics Hall of Fame. A SHIFT IN VOUCHER SUPPORT?

Most Democrats have historically rejected taxpayer-supported private-school vouchers, saying they drain resources from public schools, but a number of black lawmakers, mayors, and school officials have split with party orthodoxy on the issue, according to USA TODAY. The group includes Sacramento, Calif., Mayor **Kevin Johnson**; Newark, N.J., Mayor **Cory Booker**; and former Washington, D.C., Mayor **Anthony Williams**. **Jeanne Allen** of the <u>Center on Education Reform</u>, a Washington think tank, says the issue can no longer be dismissed by liberals as Catholic or right wing. "I actually think it has to do with more-principled people who understand and have seen how badly the existing system has hurt minority kids," she said. First proposed in 1955 by University of Chicago economist Milton Friedman -- a conservative -- private school vouchers have never fully taken root in U.S. public schools. The federal government often underwrites college tuition to attend private colleges and universities, but K-12 vouchers are presently limited to programs in a few cities that include Cleveland, Milwaukee, and New Orleans. Special Education students in some states also attend private schools with public money, but voters in nearly a dozen states have rejected voucher proposals over the past few decades.
